4. MEMBERSHIP:

a. A change to the Federation's Constitution

There are 233 recognised clubs by the State Government of which 174 are members of the Federation. Those who are not members would now become members.

There will be a special meeting just before the Federation meeting being held on Saturday 21st June 2025 where the motion will be put to the meeting and voted on.

4.1 Eligibility

Membership of the Federation shall be open to all clubs subscribing to the objects of the Federation, provided however that clubs shall be eligible for membership only if their objects embrace vehicles manufactured earlier than thirty (30) years prior to the first (1st) of January in the current year, or at the direction of the Committee, and which have members resident within the State of South Australia.

Amend to read:

4.1 Eligibility

Membership of the Federation shall be open to all clubs subscribing to the objects of the Federation, or are recognised under Section 25 of the Motor Vehicles Act for conditional registration of historic, or other prescribed vehicles, or at the direction of the Committee, and which have members' resident within the State of South Australia.

b. Whether the Government introduces mandatory inspections for 'old' vehicles annually or at time of sale, the Federation has adopted the following policy.

The Committee of the Federation moves the following motion

"The Federation of Historic Motoring Clubs SA Inc has adopted a policy that vehicles registered under Section 25 of the Motor Vehicles Act as Conditionally Registered Vehicles, be exempt from any mandatory vehicle inspections which may be introduced by the Government at some future date."

The Federation is not pre-empting any decision the Government may take but has adopted the policy to inform member clubs of the Federation's position on this matter.

Website (David Searles)

All forms relating to the ATO Not For Profit issue are on the Federation website to help you.

Car clubs do not come under the category of charity so are now taxable.

If a Federation grant is requested by a club the grant payment will go out around the same time as the event in the same financial year.

Log Books and Conditional Registration (Brian Davey)

Some orders received come without the monies or the monies are received and not the order especially when no club is given.

10 declarations still outstanding.

Brian once again advised that a club committee needs to know everything especially when a committee changes. The new committee must receive details and knowledge from the previous committee. Succession needs to happen.

Federation Motorfest (Shirley Tonkin)

There are 8 events this year and everything is ready for proof reading and then going to the printers. Looking at entries going out late May and emailed to previous entrants. Hard copies will be available to clubs

This year's dates will be from 13th October to 24th October 2025.

7. General Business:
